

This workshop is organized as a part of the planned activities of the European project entitled: 'Increasing the capacities of local administrators and officials in defining policies consistent with the Sustainable Human Development approach'. It is coordinated by the Comune di Arezzo in partnership with Provincia di Arezzo; Regione Toscana; Ucodep; Lunaria; LEI-ARCO Centro Pin, Università di Firenze; HDPC-IRC,IUSSPavia. The primary objective of the project consists in providing local Italian Authorities with the methodological tools to promote and implement local development and decentralised cooperation policies that are consistent with the sustainable human development approach - as proposed by the "Human Development Reports" published yearly since 1990 by the UNDP. The importance of such an approach is further supported by the widening recognition that an integrated approach that brings together dimensions of human development and human rights should be used in order to fully evaluate a country's development process.

The workshop will focus on human rights and human development in a policy-making perspective; examples of local and regional policy experiences inspired by the human development approach will be presented and recent initiatives by international NGOs that implemented the human rights based approach to development will be thoroughly analyzed. Thus, the workshop represents an opportunity for policy makers, researchers and NGOs to share and exchange experiences, ideas, proposals and to contribute to the general debate on how to implement policies aimed at promoting human rights and human development.
