Main research contributions:

- My work on Romance-Germanic comparative syntax, with special reference to the parametrisation of locality and of the licensing of null pronominals, contributed to the constitution of the parametric models of syntactic variation (Rizzi 1982, 1986, 2000).
- I developed the theory of locality through the study of intervention effects and the introduction of the principle known as Relativized Minimality (Rizzi 1990, 2004, 2009b). The basic concept of Relativized Minimality, implemented in slightly different forms (Minimal Link Condition, Minimal Search,...) is a core component of current formal syntactic models. More recently I developed the theory of delimitation (Rizzi 2006b, 2010, Rizzi & Shlonsky 2007), a distinct chapter of the theory of locality.
- In collaboration with Guglielmo Cinque and other colleagues, I launched the study of the cartography of syntactic structures, focusing on the fine structure of the clause and of its left periphery and the study of the syntax-pragmatics interface (Rizzi 1997, 2004, Cinque & Rizzi 2010). A dedicated subseries “The Cartography of Syntactic Structures” of the Oxford Studies in Comparative Syntax (OUP) was created in 2002 and has now published 10 cartographic volumes.
- My other major domain of research is the theory-guided study of language acquisition and development, with special reference to comparative acquisition studies on the development of the morpho-syntax in Romance and Germanic (2006a, Rizzi & Guasti 2002). Some of my previous contributions on acquisition are collected in Rizzi, L. (2000), *Comparative Syntax and Language Acquisition*, Routledge.
